Motion by Smith, supported by Kranz, to approve the minutes of the September 9, 2024, meeting as printed. Motion carried.

Motion by Kranz, supported by Everett, to approve the agenda as printed. Motion carried.

Caleb Marquard of Yellowstone Architects attended the meeting representing the proposed Cat Hospital to be located at 2339 Jolly Road, Okemos.

William Hamilton of Hagadorn Road sent another correspondence to the Board regarding the alleged zoning ordinance violation about the trucking business in his neighborhood. He is requesting the Board rethink the interpretation and administration of allowing this business to continue.

Fred Cudnohfsky of Hagadorn Road questioned if a trucking business would be permitted and stated if not, it should stop.

Mark Jaeger of Hagadorn Road has been awoken by this trucking business and questioned if the asphalt placed on this property affecting the drainage in the neighborhood.

Mark Urban-Lurain requested stripes be done on Dobie Road.

Mike Kelterborn supported Mr. Hamilton opinion that this trucking business needs to stop in the residential area.

The Board received the September 16, 2024 Planning Commission minutes.

Moton by Smith, supported by Kranz to approve the Planning Commission recommendation to issue a Special Land Use Permit to operate a Veterinary Clinic for cats providing veterinary care, surgery and boarding services on parcel #33-06-06-04-101-00 zoned B-1 Business and to only pertain to the 2339 Jolly Road address, Okemos. If in the future, patient species changes, the Special Land Use Permit will need to be amended.

Motion by Smith, supported by Kranz to approve the placement of following special assessments on the 2024 winter tax roll: Angell Acres Road and the following street light assessments: Woodlands, University Commerce Park, James Phillips Drive and Cherithbrook Drive. Motion carried.

Motion by Kranz, supported by Everett to proceed with Meridian Township Building Inspections proposal after January 1, 2025. Motion carried.

Motion by Everett, supported by Kranz to approve 25 sq ft tenant monument sign replacement with Acrisure and Wealth Advisors at 2163 University Park Drive, Okemos. Motion carried.

Supervisor Lott reported the columbarium at the Leek Cemetery has been installed. They are waiting on the picnic tables and finishing up the landscaping for the trail.
