The standby fee will be \$54,625.00; \$900.00 for all fire and rescue calls and \$600.00 per additional hour with \$90.00 per call for the command car if no additional traditional fire and rescue apparatus is required.

Brenda Seelman CPA of Clark, Schaefer and Hackett attended the meeting to present the draft of the June 30, 2023 Fiscal Year end Alaiedon Township financial audit. There was discussion about recommendations for changes that the board will review and implement.

Robert Ford of Landscape Architects and Planning attended the meeting to report to the Board on the pre-bid construction meeting for the Leek Cemetery. He will recommend a contractor to the Board at the January meeting.

Carla Clos Deputy Ingham County Drain Commissioner and Charles Smith PE of the Spicer Group attended the meeting to discuss issues related to the Dingman Drain District located in Section 5 south of Jolly Road

Lori & Wesley Stid attended the meeting to voice her unhappiness with the way the Board is working with her neighbor as he improves his property. She became disruptive and disorderly. The Board summoned law enforcement and the Stids were removed from the meeting

The Board received the December 4, 2023, Planning Commission Public Hearing minutes. Trustee Smith explained that the ordinance change was a clerical error correction.

Motion by Kranz, supported by Smith to approve Zoning Ordinance #103-18 amendment as recommended by the Planning Commission to correct Section 20.13 on Recreational Vehicles.

Motion by Kranz, supported by Leonard to approve the 25 sq ft free standing/monument sign permit application for Discover Smiles located at 2187 Jolly Road, Okemos. Motion carried.

The Board received the FYE 6-30-23 Treasurer's report. They also received the July, August, September, October, November and December 11, 2023, reports.
