# ALAIEDON TOWNSHIP BOARD OF TRUSTEES MINUTES Monday, October 13, 2025

The Alaiedon Township Board meeting held Monday, October 13, 2025 was called to order at 8:00 p.m. by Supervisor Steven Lott. Members present: Supervisor Steven Lott, Clerk Kimberly Hafley, Treasurer Scott Everett, Trustee Kurt Kranz, Trustee Beth Smith and Deputy Clerk Paulette George.

Motion by Trustee Kranz, supported by Trustee Smith, to approve the Board of Trustee minutes of the September 8, 2025 meeting as printed. Motion carried.

Motion by Trustee Smith, supported by Trustee Kranz, to approve the agenda for the meeting as printed. The agenda was updated to add Mr. Gary Hunt & Mr. Leo Urban as persons from the floor. Motion carried.

## Persons from the Floor

Gary Hunt owner of 2056 Hagadorn Road stated his concerns that the Township Zoning Ordinance no longer requires that homes must be built in a line of site that has been established in neighborhoods. A parcel adjacent to his property was recently sold and he fears the new owners will build a home behind his home's location and this will take away from his privacy in his property and his ability to hunt on his property. Mr. Hunt would like to see that a variance must be obtained by the property owners with a public hearing when a proposed home would be constructed behind other homes. The Township has not received a site plan for this parcel at the time of this meeting. The Board informed Mr. Hunt that we will talk with the Planning Commission and they will discuss this scenario at their next meeting scheduled for December 1, 2025.

Leo Urban of 2910 Holt Road attended but did not wish to speak.

# **Supervisor Lott**

- Reported that the Ingham County Road Department (ICRD) is to receive 8.7 million dollars with the newly approved State of Michigan budget. He plans to advocate to ICRD that all Ingham County Townships get a minimum of \$90,000.00 match instead of the \$45,000.00 we are currently receiving to help with keeping Ingham County Roads in better repair.
- Reported that the plans for the new pickleball facility are still moving forward and he hopes they will be attending our next meeting for their site plan approval.

# Clerk Hafley

Presented a list of proposed projects she would like to implement such as
Communication logs, Workflow Checklists, Welcome packets for new residents and
businesses, creating a standard meeting agenda and minute style for all
committees, also to keep moving forward with our website to make sure we meet
the 2027 dead line for Handicapper Accessibility Guidelines. She would also like
information for the new Lott Oesterle Walking Trail for the website. She will work
on prioritizing these items with the office staff and will keep the Board updated.

## **Trustee Smith**

- Reported that the sign pad identifying the Lott Oesterle Walking Trail at Leek Cemetery will be located near the woods edge of the new trail. The pad should be poured in the next few weeks.
- Also reported that Bill Schneider with Wildtype is ready to plant the area around the trail head with trees and native plants and remove some of the evasive species of plants that have started to take over the area. Trustee Smith plans to meet Bill Schneider with Wildtype to give an idea of where to plant the trees.
