Supervisor Lott

- Reported that he attended the ITC Listening session they held January 26, 2026 at the Okemos Event Center. During the session, he spent a lot of time with the GIS mapping team, sharing many details regarding the Township and areas of the proposed paths that will be areas of concern. This meeting was the 2nd phase of the ITC project. The 3rd phase will be after they have developed a more definitive route. They will reach out to landowners to discuss easements during this phase. The 4th phase will be submitting their application with the Michigan Public Service Commission.

Trustee Smith

- Reported that we have submitted for the final inspection of the Leek Cemetery pavilion and walking path. We will be receiving our final draw for this project in the coming months.
- Reported that at the Planning Commission workshop meeting on January 13, 2026 they discussed implementation ideas, goals and objectives for upcoming work for the Master Plan.

Clerk Hafley

- Discussed current attorney services and recommended hiring new legal counsel. Motion was made by Treasurer Everett, supported by Trustee Kranz to hire Foster Swift as Township legal counsel, noting their effective handling of current litigation matters. Motion carried.
- Reported completion of welcome packets for both residential and business use. Motion by Trustee Smith, supported by Trustee Kranz, to add the new welcome packets on the website, office counter and mailed out to new business and property owners. Motion carried.
