New Business

Motion by Trustee Kranz, supported by Trustee Smith to approve Ordinance no. 2025-03 to declare a Moratorium on the construction of farm structures, including, without limitation, silos, barns, pole barns and structures, sheds, lean-tos, or the like, while the Township considers updating the regulations regarding farm practices and the placement of farm structures on farms within the Township of Alaiedon. Motion carried.

TOWNSHIP OF ALAIEDON INGHAM COUNTY, MICHIGAN

ORDINANCE NO. 2025-03

AN ORDINANCE TO DECLARE A MORATORIUM ON THE CONSTRUCTION OF FARM STRUCTURES, INCLUDING, WITHOUT LIMITATION, SILOS, BARNS, POLE BARNS AND STRUCTURES, SHEDS, LEAN-TOS, OR THE LIKE, WHILE THE TOWNSHIP CONSIDERS THE UPDATING OF THE REGULATIONS REGARDING FARM PRACTICES AND THE PLACEMENT OF FARM STRUCTURES ON FARMS WITHIN THE TOWNSHIP OF ALAIEDON.

The Township of Alaiedon ordains:

SECTION 1. <u>Findings and Purposes.</u> The Township of Alaiedon hereby finds and declares the purpose of this ordinance to be as follows:

(A) The Board, after discussion, finds that the current regulations regarding farming and agricultural uses within the Township are inadequate to protect the environment and neighboring properties, and the general public health and welfare of the Township.

- (B) In evaluating its ordinances, the Township is considering the regulation of practices and locations of buildings that would be consistent with State regulations regarding farming with enhancements where permissible to further protect the public health and welfare of the citizens of the Township.
- (C) The Township, through its planning commission and its Board, desire to explore the appropriateness of regulations regarding the intensity of farming, location of structures, and other farm management practices that would enhance the public health and welfare.
- (D) The Township Board recognizes that the Planning Commission and the Board would need a reasonable time within which to study and implement any new regulations.
- (E) The Township Board has concluded that a moratorium on the construction of farm structures including, without limitation, silos, barns, pole barns and structures, sheds, lean-tos, and the like, for a limited period of time to meet its goals to engage in a reasonable process to determine, in consideration of the health, safety, and welfare of its citizens of the Township, whether such regulations should be implemented or not.
- SECTION 2. <u>Establishment of Moratorium.</u> The Alaiedon Township Board of Trustees hereby declares a moratorium on the farm structures as identified above for nine (9) months from the effective date of this ordinance.

SECTION 3. End of Moratorium. Upon the expiration of the nine (9) month period, the Township Board may let this ordinance lapse, or may, in its sole discretion, extend it for some further reasonable period of time, if it makes findings that such an extension meets the requirement of protecting the health, safety and welfare of the citizens of the Township.

SECTION 4. Effective Date. This Ordinance shall go into effect on the day after publication as provided by law.

Board Reports

Supervisor Lott recommended Bryan Martin to fill the vacant position on the Zoning Board of Appeal and Board of Review. Motion by Trustee Kranz, supported by Clerk Hafley to appoint Bryan Martin to the Zoning Board of Appeal and to the Board of Review. Motion carried.

Supervisor Lott reported the Taco Bell on Jolly Road will be doing an interior remodeling project in the near future.

Supervisor Lott also reported that he has been contacted about a proposed storage facility to sit on three parcels on Atrium Drive that would require a Special Land Use Permit. The individual was advised of their next steps to make an application for the Special Land Use.

Supervisor Lott also reported that ITC has reached out to inform us they are in the beginning stages of working on a new transmission line from South of Grand Ledge to North of Fowlerville. Over the next months they will be collecting information to help with a proposed route.

Treasurer Everett reported that he and his son Rhett were able to clean up the down trees on the Lott Oesterle walking path in Leek Cemetery.

Clerk Hafley reported that she was able to renew several mature bonds with the Townships Fidelity Investments Account.

Clerk Hafley also reported that she has placed an employment ad with Indeed for an additional office staff person in the township office.

Trustee Smith is working on and interpretive sign for the Lott Oesterle Trail. Foresight Supersign has submitted an estimate for the installation of the new sign. The sign is to be located on the North side of the new trail were the gravel path meets the mulch path at the wood lot line. The sign will be 24" (H) x 36" (W) single sided. The fee for this sign will be paid with the grant money we received from the Ingham County Park.

Public Comments

Karla Reust Ingham County Commissioner reported on recent changes to Ingham County Fee increases for public parks, Septic Fee Inspections and many more items. Ingham County is planning to ask the voters for several new millages in the upcoming elections.
